THE FIELDS OF FARM COLONY SUBDIVISION**





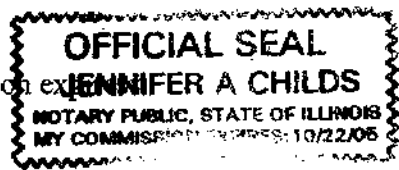
